BE IT RESOLVED, by the Council of The City of San Diego, that the City Council, acting for and on behalf of the San Diego Open Space Park Facilities District No. 1, having heard all protests against the acquisition of that property described in that Resolution of Intention No. R-266257, adopted by the City Council on July 21, 1986, hereby overrules such protests and determines that it would be in the public interest to acquire said property for open space park purposes.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to offer to purchase said property.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$525,000 as payment for said property and related costs from (en Space Park District Bond Fund 79103 is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to accept the deeds to said property without further Council action.

BE IT FURTHER RESOLVED, that this resolution does not include the finger-canyon lot or the seven lots north of said lot as discussed in this meeting, and the issue of whether or not to attempt to purchase the finger-canyon lot plus the seven lot. north of said lot is hereby continued to the Council meeting of August 19, 1986, at 2:00 p.m. for further review and discussion.

BE IT FURTHER RESOLVED, that while the expenditure of not to exceed \$525,000 is hereinabove authorized for the purchase of the various properties in Lexington Canyon, in the event the City Council ultimately determines not to purchase the finger-canyon lot or the seven lots north of said lot, the \$525,000 authorization herein shall be reduced by the amount equal to the appraised value of said lots.
