RESOLUTION NUMBER R- 265362 ADOPTED ON AUG 1 1 1986

WHEREAS, on March 4, 1986 the City Council adopted Resolution No. R-265191 establishing the Coronado Avenue (Madden Avenue to Beyer Boulevard) Underground Utility District; and

WHEREAS, the undergrounding is to be accomplished concurrently with the Coronado Avenue Widening Project which will begin in the next several months; and

WHEREAS, the easterly District boundary in Coronado Avenue is approximately the lot line between the Otay Mesa library site and the Site 132 housing project; and

WHEREAS, the developer of Site 132 is required to widen the balance of the south side of Coronado Avenue to Beyer Way and underground the utilities; and

WHEREAS, subsequent to the establishment of the District, the developer of site 132 requested that the City consider participating in the cost of undergrounding the utilities on the south side of Coronado Avenue across from Montgomery Waller Park; and

WHEREAS, Council Policy No. 600-8, Underground Conversion of Utility Lines at Company Expense cites proximity to City parks as a criteria for the use of San Diego Gas & Electric Case No. 8209 Funds; and

WHEREAS, it is recommended that the District boundary be extended 150.5 feet which is one half of the length of the park frontage; and

WHEREAS, since the City currently owns all of the frontage involved, a noticed public hearing is not required to amend and extend the District boundary; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Page 2 of 4, line 7 of Resolution No. R-265191, adopted March 4, 1986 be amended to read "460.5 feet east of the easterly line of Beyer Boulevard," which will extend the boundaries of the existing Coronado Avenue (Madden Avenue to Beyer Boulevard) Underground Utility District 150.5 feet to one half the frontage of the park.
