ADOPTED ON AUG 11 1986

WHEREAS, San Diego County has a rural road funding deficiency which exceeds available sources of revenue; and


WHEREAS, the Transit Development Account money currently can only be used for public transit purposes in San Diego County; and

WHEREAS, the unincorporated area of the County generates approximately \$900,000 annually in Transit Development Account funds, and these monies exceed by approximately \$600,000 the amount necessary for transit projects in the unincorporated areas; and

WHEREAS, AB 3764 has been amended to protect the transit interest of the City while allowing some TDA funds to be spent on rural roads; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby expresses its support for Assembly Bill 3764 (Mojonnier), as amended July 11, 1986.
