RESOLUTION NUMBER R- 266379

ADOPTED ON AUG 11 1986

WHEREAS, the California State Legislature is considering legislation to address the problem of financing adequate school facilities; and

WHEREAS, representatives of local governmental agencies, school districts and the building industry met as the San Diego Regional Ad Hoc School Facilities Legislation Group and developed a policy statement which could be a consensus position for this region; and


WHEREAS, the Rules Committee reviewed this statement as presented in Intergovernmental Relations Department (IRD) Reports No. 86-36 and 86-39 at their meetings of July 21, and August 4, 1986, respectively; and

WHEREAS, the Rules Committee directed the IRD to revise the statement to emphasize the State of California's responsibility for providing school facility financing and to support the retention of Naylor Act provisions in the State Education Code which require a school district to offer surplus playground property to governmental agencies at less than fair market value; and

WHEREAS, the Policy Statement - School Facilities has been so revised; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Intergovernmental Relations Department be and they are hereby directed to use the revised Policy Statement - School Facilities as policy direction for advocacy on school facility financing legislation, a copy of said policy is on file in the office of the City Clerk as Document No. RR- 266379.
