David Swartzendruber	Police	\$320.00	Mr. Swartzendruber is a Detective with the Vice Unit. He suggested installing a "Tone Override" signal for Police radios. Although savings are difficult to identify this was considered to be a significant operational improvement.
Arthur Johnson	General Services	\$320.00	Mr. Johnson is a Motor Sweeper Operator with the Streets Division. He suggested a modification of the FMC sweeper broom assemblies to improve sweeping effectiveness. Although savings are difficult to identify this was considered to be a significant operational improvement.
William Paul	Fire	\$160.00	Mr. Paul is a Principal Engineering Aide with the Engineering & Development Department. He suggested the use of a shading film on Fire Communication maps to block incomplete street information. Although savings are difficult to identify this was considered to be a significant operational improvement.
Ronald Shankles	Police	\$136.95	Mr. Shankles is a Detective with the Narcotics Division. He suggested revising the method of narcotics evidence disposal. The actual first year's savings were \$6,556.50 in time.

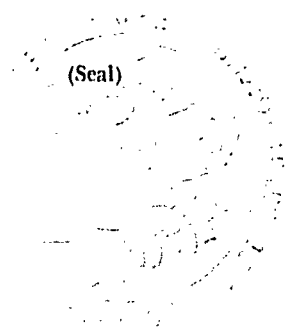
