Jude Wolinsky	Building Inspection	\$45.00	Ms. Wolinsky is an Intermediate Typist. She suggested the installation of a com-line phone for the noise abatement counter. Although savings are difficult to identify this was considered to be a significant operational improvement.
Rodney Ballard	Fire	\$25.00	Mr. Ballard is a Firefighter. He suggested issuing training bulletins to specify the uses of Rescue 28 and Foam 28. Although savings are difficult to identify this was considered to be a significant operational improvement.
