to the Stipulation and Settlement Agreement and Order entered into by Pardee Construction Co., Woodward-Clyde Consultants and The City of San Diego filed herewith as Document No. 266383 in full settlement of the lawsuits and of all claims.

- 3. That the City Manager be and he is hereby authorized to accept at a future date deeds to Lots 255, 256 and 257 of Vista Del Cerro No. 4, to be executed in favor of the City of San Diego granting to said City the real property more particularly described in said deeds.
- 4. That the City Clerk is hereby authorized and directed to cause said deeds, after acceptance by the City Manager, and a certified copy of this resolution, attested by the City Clerk under seal, to be recorded in the Office of the County Recorder.
