

RESOLUTION No. R- 266397 (R-87-32)



BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. CARY K. SALES CO., 2. STAR TOOL & SUPPLY, 3. THE DONNER COMPANY, and 4. GOULD HARDWARE & MACHINERY CO. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of SMALL TOOLS as may be required for the period of one (1) year beginning August 1, 1986 through July 31, 1987, per prices on file in the Purchasing Department, as follows:

1. CARY K. SALES CO. for Section I - Files; Section III - Hammers and Handles; and Section IX - Open, Box and Combination Wrenches; terms 1% 20 days, plus sales tax, with an option to renew contract for an additional one (1) year period with prices not to exceed 5% of prices in effect at the end of initial year.
2. STAR TOOL & SUPPLY for Section II - Miscellaneous; Section VI - Screwdrivers and Miscellaneous; and Section VIII - Impact Sockets and Accessories; terms 2% 30 days, plus sales tax.
3. THE DONNER COMPANY for Section IV - Pliers and Wrenches; terms net 30 days, plus sales tax.
4. GOULD HARDWARE & MACHINERY CO. for Section V - Shovels; and Section VII - Sockets and Socket Wrench Accessories; terms 1% 30 days, plus sales tax, with option to renew contract for an additional one (1) year period with prices not to exceed 10% of the prices in effect at the end of the initial year.
