
APPROVING MAP OF SECOND RESUBDIVISION OF THE

Wai, Registered Civil Engineer, entitled "Second Resubdivision of The Plaza at La Jolla Village Unit No. 1," being a subdivision of portions of Parcels 3 and 4 of Parcel Map No. 9580, filed January 14, 1980 in the office of the County Recorder of San Diego County, a portion of Parcel 2 of Parcel Map No. 13682, filed February 19, 1985 in the office of the County Recorder of San Diego County, and Lot 5 and portions of Lots 4 and 6 of the Resubdivision - The Plaza at La Jolla Village Unit No. 1, according to Map thereof No. 10729, filed in the office of the County Recorder of San Diego County, September 29, 1983 all in the City of San Diego, County of San Diego, State of California, is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.
