
RESOLUTION NUMBER R-266423

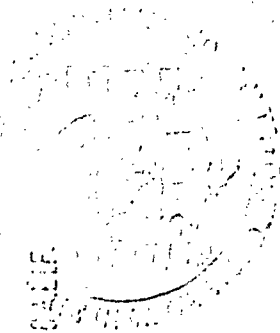
