WHEREAS, the City Council of The City of San Diego, by Resolution No. R-265036 adopted on February 10, 1986, has authorized and empowered the City Manager to request, on behalf of said City, equitable transfer under the provisions of the Comprehensive Crime Control Act of 1984 and the guidelines promulgated thereto, of forfeited property seized during operations which included participation by the San Diego Police Department, and

WHEREAS, Special Fund 10132, Seized and Forfeited Assets, has been established pursuant to the above resolution, for deposit of the proceeds of all assets received by the City through the Federal Forfeiture Program, and

WHEREAS, the San Diego Narcotics Task Force participated in an investigation which has resulted in the forfeiture of a Cessna Model 337 airplane VIN # P3370165 to the government, and

WHEREAS, the above aircraft has become eligible for equitable transfer to the City of San Diego Police Department for law enforcement purposes, said transfer conditioned on payment of existing liens, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and is hereby authorized and empowered to accept, for and on behalf of said City, equitable transfer of a Cessna Model 337 airplane, VIN Number P3370165.



BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to expend not more than the amount of \$20,000 from Special Fund 10132 solely and exclusively for operating expenses for the above aircraft for Fiscal Year 1987.
