WHEREAS, the City Council of The City of San Diego has urged CalTrans to begin the necessary feasibility and environmental studies to accomplish early construction of State Route 54 (Resolution No. R-260732 adopted by the City Council on May 21, 1984); and


WHEREAS, the construction of further improvements of State Route 54 from I-805 to State Route 125, including an eight-lane freeway, 22-foot median and eight-foot-wide outside shoulders, will reduce accidents, save lives, improve air quality and reduce energy consumption; and

WHEREAS, CalTrans is currently constructing State Route 54 between I-5 and I-805 and should complete this project during Fiscal Years 1987-88 and 1988-89; and

WHEREAS, this Council will now consider having the improvements, previously stated, completed for State Route 54 easterly to accomodate the ever increasing growth of residential homes in the easterly portions of San Diego and the South Bay;  
NOW, THEREFORE,

BE IT RESOLVED, that the Council of The City of San Diego, hereby requests that CalTrans include planning funds in its Fiscal Year 1987-88 budget for the purpose of studying the construction of State Route 54 between I-805 and State Route 125.
