WHEREAS, the Unified Port District has indicated that it would be appropriate and beneficial to expand space for the new Convention Center presently under construction; and

WHEREAS, it is appropriate for the City Council to discuss the plans for the Port District; and

WHEREAS, the Convention Center ad hoc Committee has made recommendations in regard to deadlines, changes, deletions and deferrals; and

WHEREAS, it is Council's desire to recommend to the Port District that any savings as a result of said actions be placed in a special account to fund further expansion; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendations of the Convention Center ad hoc Committee be and the same is hereby approved and supported.

BE IT FURTHER RESOLVED, that the Mayor be and she is hereby authorized to appear before the Board of Commissioners of the San Diego Unified Port District, at its special meeting scheduled on August 19, 1986 at 2:00 p.m. to present the City's position to move forward with the proposed San Diego Convention Center.

BE IT FURTHER RESOLVED, that the Port Commission be and it is hereby requested to consider accelerating the Bayside Trolley line to provide good transportation access to the Convention

Center and provide the City Council with a solution to the parking problem and Harbor Drive alignment problems.
