BE IT RESOLVED, by the Council of The City of San Diego, that this Council adopts the following findings with respect to Tentative Map No. TM-86-0237:

- 1. The proposed map is not consistent with the General Plan and University South Community Plan.
- 2. The design and proposed improvements for the subdivision are not consistent the zoning/Development regulations for the R1-5000 Zone.
- 3. The design and proposed improvements are not consistent with State Map Act.

- 4. The site is not physically suitable for the proposed development.
- 5. The design of the subdivision and the type of improvements will likely cause serious public health problems.
- 6. The design of the subdivision and the type of improvements are such that they will conflict with easements, acquired by the public at large, for access through or use of property within the proposed subdivision.
- 7. The housing needs of the region are not being met in accordance with financing and environmental policies of the City Council.

The above findings are supported by the minutes, maps and exhibits, all of which are herein incorporated by reference.

BE IT FURTHER RESOLVED, that the appeal of LEONARD B. SIMON, et al., is granted; the decision of the Planning Commission is overruled, and said Tentative Map No. TM-86-0237 is hereby denied to NEAL and DEE DESIND.
