BE IT RESOLVED, by the Council of The City of San Diego, that the City Council, acting for and on behalf of the San Diego Open Space Park Facilities District No. 1, having heard all protests against the acquisition of that property described in that Resolution of Intention No. R-266257, adopted by the City Council on July 21, 1986, being the finger-canyon lot plus the seven lots north of it in Lexington Canyon, hereby overrules such protests and determines that it would be in the public interest to acquire said property for open space park purposes.


BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to offer to purchase said property.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to accept the deeds to said property without further Council action.

BE IT FURTHER RESOLVED, that the acquisition costs of the finger-canyon and the seven lots north of it were included in the expenditure of not to exceed \$525,000 from Open Space Park District Bond Fund 79103 previously authorized for the purchase of the various properties in Lexington Canyon.
