WHEREAS, the donor has requested that the City have the sculpture independently appraised and retain and display the piece for at least two (2) years; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the generous gift by Mr. and Mrs. Burton Jones to The City of San Diego of the sculpture entitled "Stars Over Capri", created for the Capri Theatre in 1954 by the well-known sculptor Bernard Rosenthal, be and the same is hereby officially accepted.

BE IT FURTHER RESOLVED, that this Council, for and on behalf of the people of San Diego, hereby extends an expression of gratitude to Mr. and Mrs. Burton Jones for this act of civic generosity.

BE IT FURTHER RESOLVED, that the City Manager is authorized to have the sculpture independently appraised and the City Auditor and Comptroller is hereby authorized to expend a sum not
