BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. GENERAL TIRE SERVICE, 2. DAPPER TIRE COMPANY, 3. DANIELS TIRE SERVICE CO., and 4. GEO. F. KENNEDY INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing TIRES AND TUBES as may be required for the period of one (1) year beginning September 1, 1986 through August 31, 1987, as follows:

1. GENERAL TIRE SERVICE for Group I - Passenger Car/Compact Truck, Group II - Police High Speed, and Group III - Radial/Bias Tube & Tubeless - Light Trucks, for an estimated total cost of \$161,282.10; terms net, plus sales tax.
2. DAPPER TIRE COMPANY for Group V - Bias/Tube - Off Road, for an estimated total cost of \$9,557.80; terms net 30 days, plus sales tax.
3. DANIELS TIRE SERVICE CO. FOR Group VII - Inner Tubes, for an estimated total cost of \$5,947.40; terms net, plus sales tax.
4. GEO. F. KENNEDY INC. for Group IV - Radial/Bias Tube & Tubeless - Medium/Heavy Duty Truck, and Group VI - Fire Department Truck Tires, for an estimated total cost of \$185,837.85; terms net 30 days, plus sales tax.
