BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. LEARY'S FLEET TIRE SUPPLY, 2. G. F. KENNEDY, INC. and 3. A & J TIRE SERVICE are hereby accepted and the City Manager is hereby authorized to execute contracts for furnishing the City of San Diego and the Unified School District with RECAPPING OF PASSENGER AND TRUCK TIRES as may be required for the period of one (1) year beginning August 1, 1986 through July 31, 1987 per prices on file in the Purchasing Department; with option to renew contract for an additional one (1) year period as follows:

1. LEARY'S FLEET TIRE SUPPLY for Schedule I - Passenger Car/Light Truck Radial Belted Tubeless Recaps; Schedule IV - Off Road, for a total estimated cost of \$11,398.00; terms 10% 21 days, plus sales tax.
2. G. F. KENNEDY, INC. for Schedule II - Medium Duty Truck Tires for a total estimated cost of \$18,195.00; terms net 30 days, plus sales tax.
3. A & J TIRE SERVICE for Schedule III - Heavy Duty Truck Tires for a total estimated cost of \$67,111.90; terms 2% 10 days, plus sales tax.
