


RESOLUTION No. R-266466 (R- 87-343)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of FISCHER AND PORTER CO. is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing PREVENTIVE MAINTENANCE AND EMERGENCY SERVICE ON CONTROL AND MONITORING EQUIPMENT AT THREE FILTRATION PLANTS as may be required for a period of one (1) year beginning October 1, 1986 through September 30, 1987, at a cost of \$40.64 per hour, for a total estimated cost of \$40,640.00; terms net 30 days, with options to renew contract for four (4) additional one (1) year periods with price escalations each year not to exceed 8% of unit prices in effect at the end of each prior year.
