

**RESOLUTION No.** R-266473 (R-87-50 )

Adopted on SEP 8 1986

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for THE CONSTRUCTION OF NIMITZ BOULEVARD BIKEWAY BETWEEN NORTH HARBOR DRIVE AND WEST POINT LOMA BOULEVARD, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on SEP 8 1986 and bearing official Document No. W.O. 118452 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for THE CONSTRUCTION OF NIMITZ BOULEVARD BIKEWAY BETWEEN NORTH HARBOR DRIVE AND WEST POINT LOMA BOULEVARD.
4. That the City Auditor and Comptroller is hereby authorized to transfer \$6,000 from Capital Outlay Fund 30245, CIP No. 63-003 ANNUAL ALLOCATION - CHANNELIZATION IMPROVEMENTS to CIP No. 58-028 NIMITZ BOULEVARD BIKEWAY.
5. That the expenditure, not to exceed \$195,650 from CIP No. 58-028 NIMITZ BOULEVARD BIKEWAY (\$189,650 from LTF Fund 39005 and \$6,000 from Capital Outlay Fund 30245) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
