


RESOLUTION No. R-266475 (R-87-44)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That all bids theretofore received on May 1, 1986, pursuant to publication of notice calling for bids on OVERHAUL OF 54-INCH WASHWATER VALVES AT THE ALVARADO FILTRATION PLANT are hereby rejected.
2. That the revised plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for OVERHAUL OF 54-INCH WASHWATER VALVES AT THE ALVARADO FILTRATION PLANT filed in the office of the City Clerk of the City of San Diego, California, on SEP 8 1986, and bearing official Document No. W.O. 180121, be, and the same are hereby approved. 1030755
3. That the Purchasing Agent of the City of San Diego, be and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
4. That the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for OVERHAUL OF 54-INCH WASHWATER VALVES AT THE ALVARADO FILTRATION PLANT in accordance with the revised specifications.
5. That the expenditure of funds previously authorized by Resolution 265292, adopted on March 31, 1986 is hereby reauthorized for the above purpose.
