RESOLUTION NUMBER R- 266489

APPROVING MAP OF LUSK MIRA MESA RESIDENTIAL
UNIT NO. 1.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That said Council hereby finds that certain map surveyed by Robert G. Schoettner, Licensed Land Surveyor, entitled "Lusk Mira Mesa Residential Unit No. 1," being a subdivision of a portion of Parcel 4 of Parcel Map No. 13071, in the City of San Diego, County of San Diego, State of California, filed in the office of County Recorder of San Diego County, December 23, 1983, as File No. 83-469128 of Official Records, together with a portion of Camino Santa Fe and a portion of Mira Mesa Boulevard as dedicated to public use is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following streets:

Schilling Avenue, Westleigh Place, Penridge Street, Lansford Lane, Kensley Way, Granby Way, Worchester Place, Glendover Lane and a portion of Camino Santa Fe and said streets and portion of a public street are hereby declared to be public streets and portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

2. That said Council hereby rejects as a dedication that portion of Lot 112 marked "Reserved for Future Streets," as shown on said map, under the provisions of section 66440 of the Government Code.

3. That said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Mira Mesa Boulevard, adjacent and contiguous to Lots 1 through 12 inclusive, all as shown on said map within this subdivision.

4. That said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer, water, general utilities and drainage facilities, and slope rights, as granted and shown on said map and subject to the conditions set forth thereon.

5. That said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space over Lots 138 and 139 as granted and shown on said map and subject to the conditions set forth thereon.


6. That said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the building restricted easement over, upon or across those portions of Lots 1 through 12 inclusive, as granted and shown on said map and subject to the conditions set forth thereon.

7. That the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and

that said public streets and portion of a public street are accepted on behalf of the public as heretofore stated that said Council has rejected a portion of Lot 112, marked "Reserved for Future Street;" that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of water, sewer, and drainage facilities, and slope rights, as well as the easement for building restricted and open space easements, all as granted and shown on said map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

8. That the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
