
RESOLUTION NUMBER R- 266490

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of street easement deeds of PARDEE CONSTRUCTION COMPANY, a California corporation, and LUSK-SMITH/MIRA MESA NORTH, a limited partnership, executed in favor of The City of San Diego, bearing dates of May 12, 1986, and March 11, 1986, respectively, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR- 266490-1 and RR- 266490-2 granting to said City easements for public street purposes in a portion of the Northwest Quarter of the Southwest Quarter of Section 35, Township 14 South, Range 3 West, San Bernardino Meridian, and in a portion of Parcel 5 of Parcel Map No. 13071, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and the same are hereby named CAMINO SANTA FE, PENRIDGE STREET and SCHILLING AVENUE.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
