WHEREAS, the subdivider is the only affected property owner; and


WHEREAS, the subdivider will erect all the necessary street name signs; and

WHEREAS, this street name change is at no cost to the City; NOW, THEREFORE,

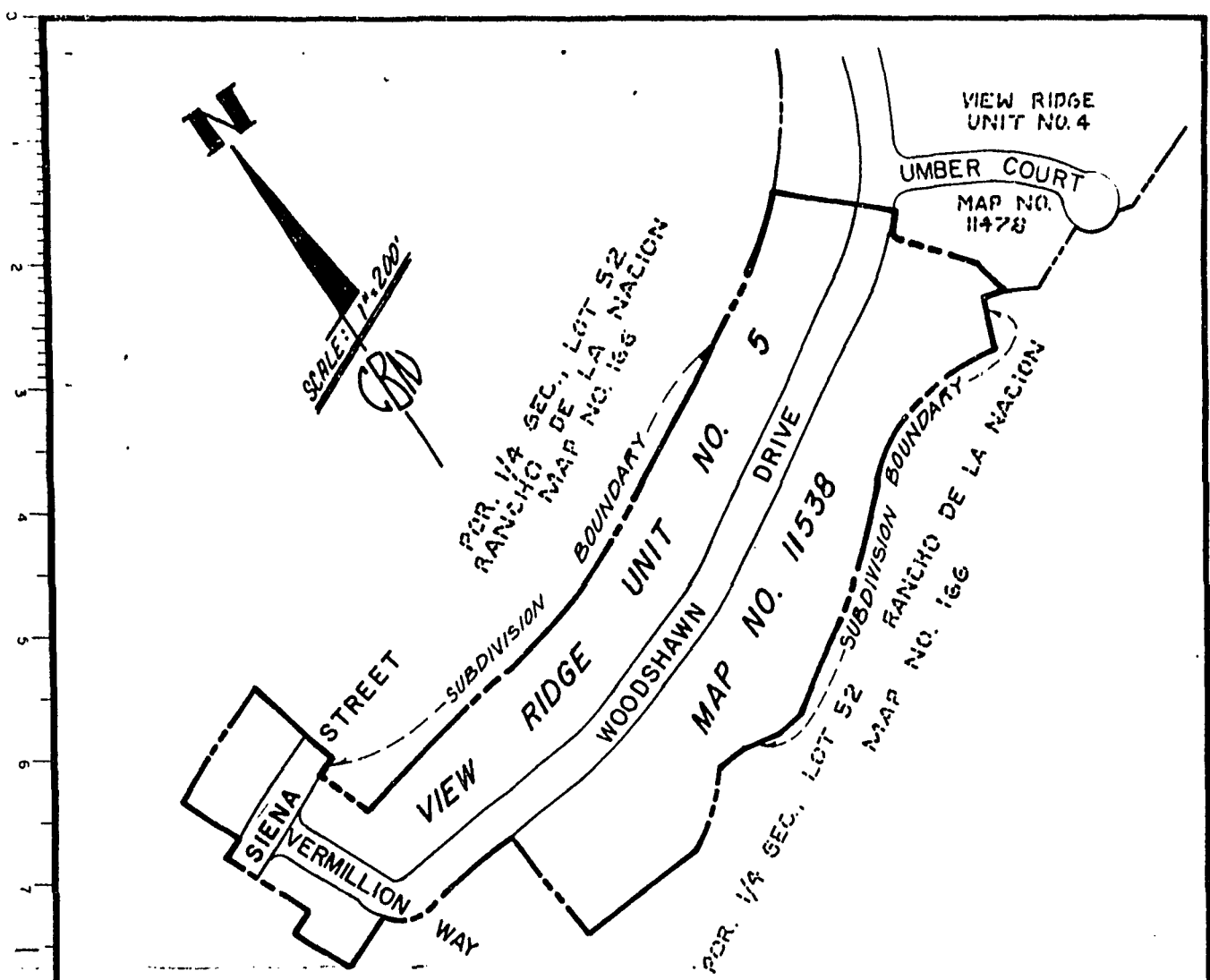
