

RESOLUTION NUMBER R- 266510

ADOPTED ON SEP 8 1986

WHEREAS, in 1973 the Council of The City of San Diego adopted the sign ordinance, setting forth standards for on-premises signs in commercial and industrial zones; and

WHEREAS, said ordinance, inter alia, established an abatement period to bring then existing nonconforming signs into compliance with the new standards; and

WHEREAS, since 1973 the Council, at the request of the sign user community, has granted four separate extensions to said abatement period for a total abatement period extending from 1973 to 1988, a period of fifteen years; and

WHEREAS, the most recent extension of the abatement period, set forth in San Diego Municipal Code Section 95.0123, adopted in 1983, grants an extension of time to those sign owners who enter into agreements with the City of San Diego stipulating that the subject nonconforming signs shall, at the owners initiative and expense, be brought into compliance with the City's sign regulations no later than March 1, 1988; and

WHEREAS, to assure the sign using community of the Council's intent with regard to further extensions of time and to encourage parties to conditional extension of time agreements to faithfully execute the terms of their agreements, namely the bringing of nonconforming signs into compliance with the City's sign regulations; NOW, THEREFORE,



BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby declares its firm intent to adopt no ordinance or resolution extending current abatement periods or creating new abatement periods for bringing nonconforming on-premises signs into compliance with the current sign code, where the current abatement program stipulates such compliance no later than March 1, 1988.

BE IT FURTHER RESOLVED, that the Sign Code Administrator is hereby directed to develop and implement forthwith a cooperative program to encourage and assist owners of signs subject to conditional extension of time agreements in the faithful execution of the terms of their agreements.
