BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager hereby acknowledges and accepts the generous contribution of \$39,500 from an anonymous donor and directs that said contribution be deposited in Special Trust Fund 10129 to be used exclusively for the purchase of a firearms training system (F.A.T.S.) to be used in the Police Academy and In-Service Training;

2. That the expenditure of not more than \$39,500 from Special Trust Fund 10129 is hereby authorized solely and exclusively for the purchase of a firearms training system (F.A.T.S.) to be used in the Police Academy and In-Service Training.
