WHEREAS, since the summer of 1977, The City of San Diego has contracted with the County for enforcement of ordinances that regulate dogs on City public beaches, adjacent parks and adjacent walkways; and

WHEREAS, County Animal Control staff is authorized to enforce the ordinances that prohibit dogs on most beaches (exceptions: a portion of Fiesta Island and the sand plug in the mouth of the San Diego River) between 9:00 a.m. and 6:00 p.m.; and

WHEREAS, that at all other times except in the two exempt areas, dogs must be leashed, and that persons having control of dogs must clean up after them; and

WHEREAS, this extension of the agreement contemplates a continuation of the present level of service and also authorizes the County to expend not more than \$11,700 to purchase a van to transport its staff from headquarters to the beach and from one beach sector to another; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, a FIFTH SUPPLEMENTAL AGREEMENT TO THE BASIC AGREEMENT, for Animal Regulation service with the County of San Diego, for the provision of enforcement activities in respect to animal control regulations on the beaches and beach parks, during the period

July 1, 1986 through June 30, 1989, pursuant to the terms and conditions of the FIFTH SUPPLEMENTAL AGREEMENT, on file in the office of the City Clerk as Document No. RR-266519.
