
ADOPTED ON SEP 8 1986

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the San Diego Ecology Centre, to provide recycling and resource recovery education, information and action programs, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 266528 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$55,000 from the General Fund (General Services Department, Refuse Disposal Division budget), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
