WHEREAS, General Dynamics Corporation has donated \$15,265 to the Private Industry Council (PIC) of the San Diego Regional Employment and Training Consortium (RETC) for the purpose of providing a private summer youth employment program under which the cost of ten (10) positions at General Dynamics will be covered; and

WHEREAS, this program will operate during the summer months of 1986 for youth who will be JTPA eligible, and shall be known as the Summer Hire Intern Project; and


WHEREAS, The City of San Diego, Regional Youth Employment Program (REGY) agrees to provide services to operate the project for the Corporation and RETC; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the San Diego Regional Employment and Training Consortium (RETC), for the amount of \$15,265, for the purpose of hiring ten young adults and a Coordinator during the summer of 1986, for a seven-week

training opportunity, under the terms and conditions set forth in
the agreement on file in the office of the City Clerk as Document
No. RR- ~~266529~~.
