WHEREAS, on June 24, 1985, the City entered into drug and alcohol rehabilitation services agreements with Villa View, Mission Bay, Hillside and Scripps Memorial Hospitals to provide services to City employees enrolled in the CITYMED Health Plan; and

WHEREAS, these hospitals were recommended to the City by its consultant (The Epler Company) based upon treatment program comparisons comparable to the coverage offered by the City's other health plans within commonly accepted effective treatment technique; and

WHEREAS, the proposed First Amendments to the agreements with the four listed hospitals will extend the coverage for a one-year period and provide continued coverage at significantly reduced rates from those normally paid by the CITYMED Health Plan and its enrollees for similar services; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, the First Amendments to Agreements with Villa View, Mission Bay, Hillside, and Scripps Memorial Hospitals, to extend the terms of the basic agreements for one-year period from August 1, 1986 through July 31, 1987, for the purpose of providing alcohol and drug rehabilitation treatment under the CITYMED Health Plan, pursuant

to the terms and conditions of the First Amendments to
Agreements, on file in the office of the City Clerk as Documents
No. RR-266537¹, RR-266537²-2, RR-266537³-3, and
RR-266537⁴-4.
