


RESOLUTION No. R-266570 (R-87-351)

Adopted on SEP 15 1986

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF DRAINAGE FACILITIES FOR EASTGATE TECHNOLOGY PARK, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on 9-15-86 and bearing official Document No. W.O. 118150 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF DRAINAGE FACILITIES FOR EASTGATE TECHNOLOGY PARK.
4. That the City Auditor and Comptroller is hereby authorized to transfer \$50,000 within the Sewer Revenue Fund 41506 from Unallocated Reserve 70697 to Sewer Main and Manhole Maintenance Program 70440.
5. That the expenditure, not to exceed \$272,225 (\$222,225 from Industrial Development Fund 30248, CIP No. 39-040 PUEBLO LANDS - DEVELOPMENT; and \$50,000 from Sewer Revenue Fund 41506, Sewer Main and Manhole Maintenance Program) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.

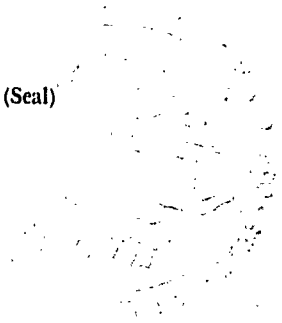
