

RESOLUTION NUMBER R- 266573

ADOPTED ON SEP 15 1986

APPROVING MAP OF MISSION HILLSIDE
CONDOMINIUMS.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by James L. Meyer, Licensed Land Surveyor, entitled "MISSION HILLSIDE CONDOMINIUMS being a subdivision of Lots 5 and 6 in Block 190 of Middletown, according to map thereof made by J. E. Jackson, filed in the office of the County Recorder of San Diego County, together with Kettner Boulevard (formerly Arctic Street) and portions of Pringle Street and Arctic Street, all as closed and vacated to public use, all in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

That said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Mission Hills Boulevard, adjacent and contiguous to Lot 1, all as shown on this map within this subdivision.


That said Council hereby accepts on behalf of The City of San Diego, the easement with the right of ingress and egress for the construction and maintenance of pedestrian, sewer and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, that those certain abutters' rights of access, together with the easement with the right of ingress and egress for the construction and maintenance of pedestrian, sewer and drainage facilities, all as shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to record the street vacation of Kettner Boulevard and a portion of Pringle Street, approved by Resolution No. R-264073 on September 16, 1985, concurrently with the filing of the map.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
