

RESOLUTION NUMBER R- 266584

ADOPTED ON SEP 15 1986

WHEREAS, San Diego County ("County") faces a crisis in its regional justice system by virtue of the inadequacy of present facilities, particularly jails and courtrooms; and

WHEREAS, the County is and has been under court order for several years to reduce overcrowding in the jail despite implementation of twenty-nine programs to reduce jail population; and

WHEREAS, a recent study by an independent consultant projected the facility space need in the year 2005 to cost \$420 million, with an annual debt service of \$58 million over a twenty-year period; and

WHEREAS, the County has placed the following proposition on the November 1986 general election ballot:


SHALL APPROVAL BE GIVEN TO (1) AN ORDINANCE OF THE COUNTY OF SAN DIEGO IMPOSING A ONE-HALF OF ONE PERCENT TRANSACTIONS AND USE TAX FOR A TERM NOT TO EXCEED FIVE YEARS TO BE USED SOLELY FOR THE PURPOSE OF IMPROVING, EXPANDING, CONSTRUCTING OR ACQUIRING SITES FOR REGIONAL JUSTICE FACILITIES TO THE EXTENT STATE OR FEDERAL FUNDS ARE NOT MADE AVAILABLE TO THE COUNTY OF SAN DIEGO SPECIFICALLY FOR SUCH PURPOSES, AND (2) AN INCREASE IN THE APPROPRIATION LIMIT OF THE COUNTY OF SAN DIEGO IN THE AMOUNT EQUAL TO THE AMOUNT OF SUCH TAX TO BE COLLECTED?

NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of said City, does

hereby endorse the County of San Diego's action to place the
above proposition before the voters, and further urges the voters
of San Diego County to approve this important ballot measure.

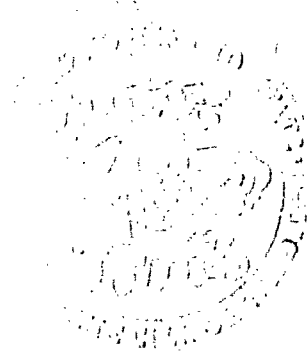
