WHEREAS, pursuant to Resolution Number R-264839 adopted by the City Council on January 13, 1986, the City Clerk submitted an application to the National Historical Publications and Records Commission; and

WHEREAS, such application requested funding for the hiring of personnel to inventory the records of City departments; and

WHEREAS, the National Historical Publications and Records Commission has awarded the City of San Diego \$72,588 to be used for the inventory of City records; and

WHEREAS, it is now necessary that Council authorize acceptance of said grant funds provided under the authority of 44 U.S.C. 2504; and

WHEREAS, said grant funds are to be administered in conformity with the application dated January 6, 1986, as modified by Richard A. Jacobs' letter of June 24, 1986, the letters following thereafter and specified in the NHPRC notification dated August 18, 1986, and the revised project budget all on file in the office of the City Clerk as Document No. RR- 266585 ; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the grant funds authorized by the National Historical Publications and Records Commission in its Grant No. 86-114, as indicated in its letter to the City Clerk dated August 18, 1986,

be and the same is hereby accepted, pursuant to the terms and conditions set forth therein.

BE IT FURTHER RESOLVED, that the City Clerk be and he is hereby directed to apply said grant funds and such matching funds as have been appropriated by the Council for said archives project pursuant to the terms and conditions set forth in the grant application and the grant as controlled by National Historical Publications and Records Commission policies and procedures, copies of which are contained in a complete subject matter packet on file in the office of the City Clerk as Document No. RR- 266585.
