- 3. That this Council certifies it has sufficient funds to operate and maintain the project.
- 4. That this Council certifies it will provide construction plans and specifications to the state within one year of the appropriation of funds under this program and will commence work immediately after state approval.
- 5. That the City Manager or his representative be, and he is hereby authorized to coordinate, process, and execute all contracts, agreements, amendments and ancillary documents within the scope of the application, said application is on file in the office of the City Clerk as Document No. RR-266586.
- 6. That the City Auditor and Comptroller be, and he is hereby authorized to establish special funds which will earn their own interest in accordance with grant requirements.
