RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE APPLICATION FOR HISTORIC PRESERVATION GRANT FUNDS FROM THE CALIFORNIA PARK AND RECREATIONAL FACILITY ACT OF 1984.

WHEREAS, the Legislature under the California Park and Recreational Act of 1984 has authorized the establishment of a Historic Preservation Grant Program, providing matching funds to the political subdivisions of the State for historic preservation projects; and

WHEREAS, the California Office of Historic Preservation in the Department of Parks and Recreation is responsible for the administration of the program within the State, setting up necessary rules and procedures governing application by local agencies under the program; and

WHEREAS, said adopted procedures established by the Department of Parks and Recreation require the applicant to certify by resolution the approval of applications and the availability of local matching funds prior to submission of said applications to the State; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the City Manager or his representative be, and he is hereby authorized to submit applications to secure FY 1987 Historic Preservation Program Funding as described in Manager's Report No. 86-380.

2. That the City Manager or his representative be, and he is hereby authorized to coordinate, process, and execute all contracts, agreements, amendments and ancillary documents within the scope of the application, said application is on file in the office of the City Clerk as Document No. RR- 266586.

3. That this Council agrees that all required local matching funds will be provided for the project.

4. That the City Auditor and Comptroller be, and he is hereby authorized to establish special funds which will earn their own interest in accordance with grant requirements.
