WHEREAS, during Council discussion of the Mount Hope Cemetery budget on June 12, 1986, the Council directed the City Manager to return that the proposed method of landscaping the area in front of the Mount Hope Cemetery along Martin Luther King Way; and

WHEREAS, the area in question is a strip of land between the Mount Hope Cemetery fence and the sidewalk across from the Gateway Center Project currently being developed under the auspices of the Southeast Economic Development Corporation ("SEDC"); and

WHEREAS, SEDC is currently undertaking street improvements along Martin Luther King Way in front of the Gateway Center Project; and

WHEREAS, the work includes landscaping along the north side of the road adjacent to Gateway Center but not the landscaping on the south side adjacent to the Mount Hope Cemetery; and

WHEREAS, the landscape architect retained by SEDC has designated a landscape plan for the area in front of Mount Hope and SEDC proposes that the landscaping be done as an addition to the contract for the work in front of Gateway Center; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to direct SEDC, for and on behalf of said City, to carry out the landscaping along Martin Luther King Way adjacent to Mount Hope Cemetery, and to carry out certain security improvements at the Mount Hope Cemetery.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$48,400.00 from CIP 38-008.2, Mt. Hope Cemetery - Division 13 Development (Capital Outlay Fund 30245), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
