WHEREAS, in June, 1982, The City of San Diego and Children's Hospital entered into an Agreement, filed in the Office of the City Clerk as Document No. RR-256446, regarding the performance of evidentiary examinations by said Hospital for The City of San Diego, to be effective until June 30, 1986; and

WHEREAS, in 1985 the State Legislature enacted certain statutory guidelines for hospital performance of evidentiary examinations and provided for the Office of Criminal Justice Planning to establish the protocol for the examinations; and

WHEREAS, the new protocol has not yet been finalized by the Office of Criminal Justice Planning; and

WHEREAS, said contract needs to be extended under the same terms and conditions on a month-to-month basis until a new contract agreement can be reached in order to provide authority for payment to the Hospital for the examinations currently being performed; and

WHEREAS, the sum of \$250,000 is anticipated to be expended from Fund 100 to provide for said examinations during Fiscal Year 1986-1987; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an Amendment to Agreement with Children's Hospital in accordance with the terms

and conditions of the Agreement on file in the office of the City Clerk as Document No. RR-256446.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to expend a sum not to exceed \$250,000 from Fund 100 solely and exclusively for the above purposes, on an as required basis during Fiscal Year 1986-1987.
