WHEREAS, AVCO COMMUNITY DEVELOPERS, subdivider of RIDGEGATE LA JOLLA, under an agreement filed in the office of the City Clerk as Document No. RR-251663, was required to install certain improvements in said subdivision; and

WHEREAS, during construction of the improvements, it was determined that the southerly portion of the development (Lots 148 through 168) had slope stability problems; and


WHEREAS, said subdivider has requested an extension of time in which to complete the work; and

WHEREAS, the Engineering and Development Director and the City Manager have recommended that such extension of time be granted said subdivider in which to complete the required improvements; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that AVCO COMMUNITY DEVELOPERS, subdivider of RIDGEGATE LA JOLLA, under that certain agreement made with THE CITY OF SAN DIEGO, on file in the office of the City Clerk as Document No. RR-251663, is hereby granted an extension of time to January 1, 1987, within which to complete the improvements required by said agreement.

BE IT FURTHER RESOLVED, that the City Engineer be and he is hereby authorized and empowered to approve the proposed slope repairs for Lots 148 through 168.
