


RESOLUTION No. R- 266600 (R- 87-36)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of CASCIO AND SON INC. is hereby accepted and the City Manager is hereby authorized to execute a contract for COMPLETE PALM TRIMMING SERVICE FOR TWO-THIRDS (2/3) OF APPROXIMATELY TWENTY-TWO THOUSAND, EIGHT HUNDRED TWENTY-ONE (22,821) PALM TREES (COCOS AND WASHINGTONIA) as may be required for a period of twelve (12) months beginning September 1, 1986 through August 31, 1987, per prices on file in the Purchasing Department; terms 1% 20 days, with options to renew contract for two (2) additional one (1) year periods with a price escalation not to exceed 10% in the first option year and 14% in the second option year.
