
RESOLUTION NUMBER R- 266602

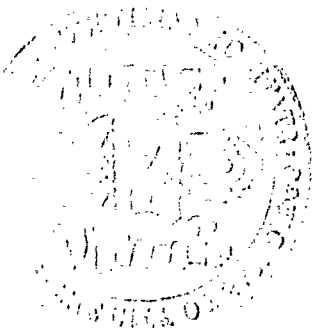
