


RESOLUTION NUMBER R- 266607

BE IT RESOLVED, by the Council of The City of San Diego, that Alternative 11A cited in SANDAG's "Route 125 North Location Analysis," dated June, 1984, on Pomerado Road in the proposed Scripps Miramar Ranch Annexation Area is hereby adopted as the preferred alignment.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to designate eucalyptus trees as the proper type for landscaping and provide that the emergency access road be maintained to the standards of the Fire Department of the Cities of Poway and San Diego.
