He suggested the installation of 1½" galvanized water lines in the scum vacuum trailer to generate circulation and agitation. This is expected to save \$7,538.35 in time. This is a partial award pending a 12-month review.
Kenneth Norton	General Services	\$ 757.40	Mr. Norton is a Senior Communications Technician in the Communications & Electrical Division. He suggested modifying the Automatic Receiver selector modules of the tone receivers. This is expected to save \$5,049.30 in material. This is a partial award pending a 12-month review.
