WHEREAS, the TRANSPORTATION ELEMENT OF THE CENTRE CITY SAN DIEGO COMMUNITY PLAN adopted in 1976 is outdated and no longer adequate to serve current and future development patterns and intensity; and

WHEREAS, the consultant prepared Centre City Transportation
Action Program has been completed, including recommendations for
improving the transportation system in downtown; and

WHEREAS, in order to prepare a revised TRANSPORTATION ELEMENT OF THE CENTRE CITY SAN DIEGO COMMUNITY PLAN, guidance from the City Council in the form of policy direction is necessary; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That this Council affirms that the Centre City transportation system should support development intensity not restrict it.
- 2. That this Council recognizes that in order to facilitate access to Centre City, traffic should be accommodated within the existing right-of-way by means of management techniques.
- 3. That this Council establishes public transit as a high priority in the development of a comprehensive transportation system and acknowledges that support for public transit should be by new or existing discretionary funds.

- 4. That this Council accepts the premise that capital and operating costs for transportation should be supported by new sources of public and private funding.
- 5. That this Council initiates the preparation of a comprehensive parking study and program for Centre City in conjunction with the TRANSPORTATION ELEMENT OF THE CENTRE CITY SAN DIEGO COMMUNITY PLAN.
- 6. That this Council continues to use the Transportation Action Program as a major source document in the preparation of the TRANSPORTATION ELEMENT OF THE CENTRE CITY SAN DIEGO COMMUNITY PLAN.
