## RESOLUTION NUMBER R- 266620 ADOPTED ON SEP 1 6 1986

WHEREAS, John Duffy, the twenty-sixth Sheriff of San Diego County, was born in Galveston, Texas, June 10, 1930 and moved to San Diego at age three months; and

WHEREAS, Sheriff Duffy began his peace officer career on May 25, 1953, when he was appointed a Deputy Sheriff for San Diego County; and

WHEREAS, John Duffy was first elected Sheriff of San Diego County in 1970 and has been re-elected in the primary elections of 1974, 1978, 1982 and 1986; and

WHEREAS, the Sheriff is a graduate of the FBI National Academy, the Police Executive Institute and was one of only twenty-three law enforcement executives in the nation to complete the Police Foundation seminar, covering the policing systems in four European countries; and

WHEREAS, the Sheriff is immediate past president of the Police Executive Research Forum, serves on the board and is chairman of the Law and Legislative Committee of the National Sheriff's Association, has served the Reagan Administration as a member of the National Institute of Justice and the Justice-Treasury Advisory Committee on State and Local Law Enforcement Training; and

WHEREAS, Sheriff Duffy is a board member and past president of both the California State sheriff's Association and the

California Peace Officer's Association and past president and active member of the San Diego County Police Chiefs and Sheriff's Association and was then-Governor Reagan's only Sheriff appointment to the California Council on Criminal Justice; and

WHEREAS, the Sheriff has served in several criminal justice and law enforcement advisory capacities at all levels of government and is currently serving Governor Deukmejian on the Executive Committee of the California Stop Crime Coalition and the Peace Officer Memorial Committee; and

WHEREAS, Sheriff Duffy is a board member of the Variety Club of San Diego and an advisory board member of the Institute for Burn Medicine and the San Diego Boy Scout Council and he has received the Law Enforcement Commendation Medal from the National Society of the Sons of the American Revolution, the Golden Man and Boy Award from the San Diego County Boy's Clubs and in 1980, was selected "Irishman of the Year" by the Friendly Sons of St. Patrick; and

WHEREAS, the Nice Guys, a San Diego organization that has, since 1979, raised nearly a million dollars to aid San Diego charities and needy individuals, has named Sheriff John Duffy the 1986 John Helmer "Nice Guy of the Year;" and

WHEREAS, Sheriff Duffy will be formally honored at the John Helmer "Nice Guy of the Year" banquet on September 20, 1986; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that September 20, 1986 be and it is hereby declared to be "Sheriff John Duffy Day" in The City of San Diego.
