WHEREAS, Marie Hitchcock's willingness to expend countless hours and effort in creating original puppet shows of a wholesome and entertaining character has imparted to the childhood realm of fantasy a high degree of moral comprehension within an entertainment medium; and

WHEREAS, the many citizens and parents of the children of the City of San Diego and the County of San Diego have unhesitatingly expressed their desire to have the Puppet Theatre renamed the Marie Hitchcock Puppet Theatre; and

WHEREAS, the Balboa Park Committee unanimously recommended renaming the Puppet Theatre in Balboa Park as the Marie Hitchcock Puppet Theatre in honor of her seventy-fifth birthday in recognition of her devotion and expenditure of time and effort; and


WHEREAS, the Park and Recreation Board voted unanimously to rename the Puppet Theatre the Marie Hitchcock Puppet Theatre;
