


RESOLUTION No. R-266625 (R-87-419)

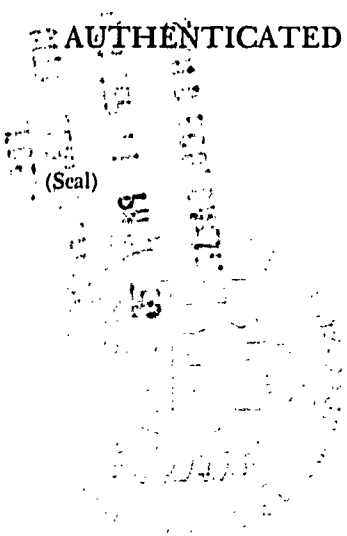
