WHEREAS, the City has entered into exclusive negotiation and right of entry agreements with the Sheraton Corporation and the Hospital Corporation of America covering the planned development of a hotel and an aerobic center, respectively, which would occupy the existing Torrey Pines Golf Course driving range and the sites of other golf support facilities; and

WHEREAS, City Manager Report No.86-417 dated September 5, 1986, recommends a conceptual relocation plan for the driving range and other golf support facilities, which is supported by the City Planning Commission and the City Park and Recreation Board; and

WHEREAS, the aforementioned exclusive negotiation and right of entry agreements provide for the funding of relocations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the conceptual relocation plan recommended by City Manager Report No. 86-417 is hereby approved.
