WHEREAS, the Council of the City of San Diego, by Resolution Number R-264718, adopted on December 16, 1985 authorized and empowered the City Manager to execute an agreement with Vickie Romero and Associates, a consultant, regarding an evaluation of and recommendations concerning Human Relations Training within the San Diego Police Department, and

WHEREAS, pursuant to the agreement, Vickie Romero and Associates has completed its study and has submitted a final report dated April 1986 containing both findings and recommendations, NOW, THEREFORE,

BE IT RESOLVED, that the Council of The City of San Diego hereby accepts the above consultant's report.

BE IT FURTHER RESOLVED, that the City Manager be and is hereby directed to form an implementation task force to be headed by a Deputy Chief of Police and to include two members of the Citizen's Advisory Board for Police/Community Relations, selected male and female minority officers, and respected educators in the area of Human Relations Training for the purpose of developing an implementation plan and schedule and the fiscal impact of such implementation.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to report back to the Public Services and Safety Committee with the recommendations of the implementation task force.
