


**RESOLUTION No.** R-266648 (R-87-423 )

Adopted on SEP 22 1986

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for MAINTENANCE SURFACING VARIOUS CITY STREETS GROUP "W" FY 87, San Diego, California filed in the office of the City Clerk of the City of San Diego, California, on SEP 22 1986 and bearing official Document No. RR-266648 be, and the same are hereby approved.
2. That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.
3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for MAINTENANCE SURFACING VARIOUS CITY STREETS GROUP "W" FY 87.
4. That the expenditure, not to exceed \$5,704,342 (\$5,187,542 from Gas Tax Fund 30219; \$372,700 from Water Utility Operating Fund 41500; and \$144,100 from Sewer Revenue Fund 41506) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
